

STUDENT SUCCESS

GOAL: TO ENABLE STUDENTS TO ACHIEVE THEIR EDUCATIONAL AND CAREER GOALS

Objectives:

- a) To strengthen students' basic academic skills (English comprehension, Writing, Reading and Mathematics). Ongoing
- b) To increase collaboration and coordination between the Academic Resource Centre, Counselling, Career Centre, Registrar and other campus departments to deliver services and resources that enhance student achievement/success.

 Ongoing
- c) To improve student retention by implementing an effective Early Alert System from Early Identification > Intervention > Impact. Ongoing
- d) To expand and improve academic advising and other student support services.

 Ongoing
- e) To improve access, recruitment, enrolment, and course/programme completion rates of students. Ongoing
- f) To develop and implement a comprehensive plan to serve students with disabilities. (Fall 2013)
- g) To provide students with an enriching campus-based intellectual, social, and cultural environment and experience. Ongoing

INSTRUCTIONAL TECHNOLOGY

GOAL: TO MAXIMIZE THE INTEGRATION OF INSTRUCTIONAL TECHNOLOGY INTO THE CORE OF EVERY ACADEMIC AND VOCATIONAL/TECHNICAL PROGRAMME

Objectives:

- a) To provide on-going faculty training in the use of instructional technology aimed at optimizing student learning. Ongoing
- b) To equip all classrooms with Smart Boards by Fall 2015.
- c) To create a computer lab, housing 20-25 workstations, by August 2012.
- d) To assess the feasibility of creating a largely paperless library and expand the current virtual library by January 2015.
- e) To maximize student access to and mastery of tools and technologies to support their learning, life and career pursuits. Ongoing
- f) To train all faculty in the use if the Moodle platform by Fall 2012. Ongoing
- g) All students, irrespective of programme, will achieve and/or demonstrate a specified minimum degree of computer literacy

DISTANCE EDUCATION

GOAL: TO INCREASE ACCESS TO HIGHER EDUCATION BY EXPANDING OPPORTUNITIES FOR ONLINE INSTRUCTION

Objectives:

- a) To develop future class schedules reflecting a greater variety of online options.

 Ongoing
- b) To develop and implement standards and practices for ensuring quality online instruction. January 2013
- c) To create an online component in every degree and certificate programme by 2015.

ASSESSING STUDENT LEARNING OUTCOMES

GOAL: TO DEVELOP AND ASSESS STUDENT LEARNING OUTCOMES (SLOs) FOR ALL COURSES, CERTIFICATE, DIPLOMA AND DEGREE PROGRAMMES

Objectives:

- a) To develop learning outcomes for every course, certificate, diploma and degree programme in the Bermuda College curriculum. May 2012
- b) To establish a Learning Outcomes Team (LOT) consisting of a cross-section of faculty. October 2012
- c) To implement course/programme changes as a consequence of assessment results. Fall 2013
- d) To achieve proficiency in assessing Student Learning Outcomes consistently using data to prove and improve student success. Fall 2014
- e) To institutionalize a process of continuous quality improvement incorporating results derived from assessment. Fall 2015
- f) To provide on-going training and support in the development and use of assessment plans and results. Ongoing

PARTNERSHIPS AND ARTICULATION AGREEMENTS

GOAL: TO EXPAND INSTITUTIONAL PARTNERSHIPS AND ARTICULATION AGREEMENTS

Objectives:

- a) To complete a review and revision of all existing articulation agreements with baccalaureate degree granting institutions. [COMPLETE]
- b) To ensure that all colleges and universities with whom Bermuda College has articulation agreements allow students to make a seamless and timely transfer. [COMPLETED]
- c) To forge new partnerships and strengthen existing ones with industry aimed at enhancing student recruitment, programme/curriculum/resource development; instructional capital, job placement and continuing education & training.

- d) To assess the feasibility of developing new degree and certificate programmes in conjunction with public, private and non-profit sector partners. Ongoing
- e) Annually review articulation agreements with a view to contact institutions at least 6 months prior to the end of agreement to renew, update or terminate agreement Ongoing

- b) To explore the prospect of resurrecting a Faculty Senate. January 2013 [COMPLETED]
- c) Develop a procedure for recording and reporting of the re-training scholarship funds on a semester basis. Report to include amounts committed by WFD and those that have been realized by student. December 2015
- d) Review the policy of high school students paying an application fee for applications received prior to 01 December. October 2015

Objectives:


- a) To determine the feasibility of collaborating with ministries and agencies in expanding community activities offered. January 2013
